FACT: SQ 832 permanently ties Oklahoma's minimum wage to the cost of living in San Francisco

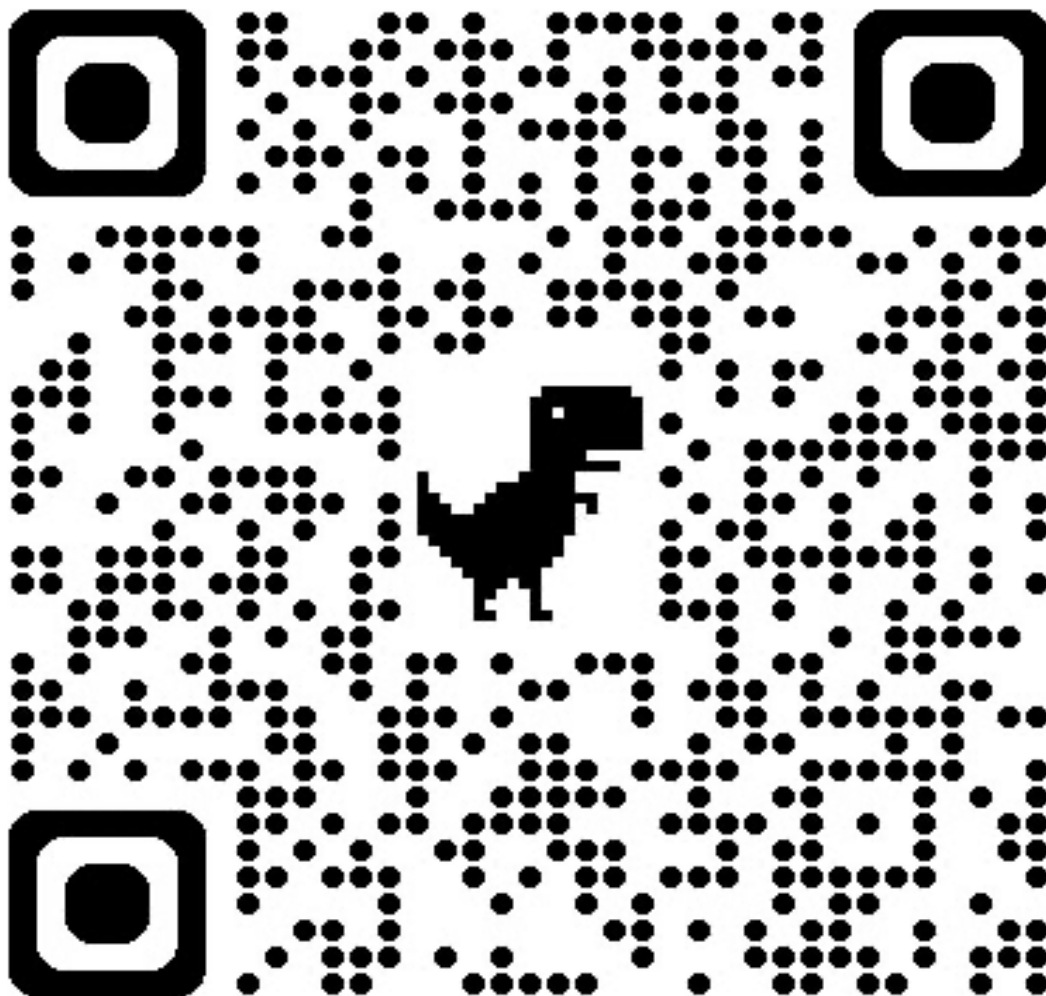
